

## NOTICE TO SHAREHOLDERS OF

### Nordea 1 – Global Climate and Environment Fund

#### Shareholders invested into institutional share classes only

Following the decision of the Board of Directors (“**Board**”) of Nordea 1, SICAV (the “**Company**”) to soft close Nordea 1 – Global Climate and Environment Fund (the “**Fund**”) as of 26 February 2021 for an undetermined period of time (the “**Soft Closure**”), inflows from existing clients have continued, especially from the institutional segment.

In order to further protect the interests of all shareholders and to ensure the continued efficient management of the Fund, the Board has decided to implement a daily cap on subscriptions and conversions in the Fund of one million Euro (EUR 1,000,000), or the equivalent thereof, per shareholder and for all institutional share classes only (the ISINs are detailed in Appendix I to this notice), with effect from 25 June 2021.

The flow development in the Fund will be continuously monitored and these additional restrictions for the institutional share classes shall be reassessed should they be insufficient to maintain flows in the Fund at an acceptable level.

Terms used in this Notice shall have the same meaning as those in the Prospectus, unless stated otherwise.
