### NOTICE TO UNIT HOLDERS

Dear Unit-holder,

The Board of Directors of Nordea Investment Funds S.A (the "**Management Company**") hereby informs you as unit-holder of Nordea Asset Allocation Fund (the "**Fund**") about certain changes in relation to the Fund:

#### I. Change of the statutory auditor of the Fund

Following the decision of the Annual General Meeting of Nordea Bank AB (publ) taken on 19<sup>th</sup> March 2015 to appoint Öhrlings PricewaterhouseCoopers AB as the auditor, the Board of Directors of the Management Company decided on 23<sup>rd</sup> of March 2015 to appoint PricewaterhouseCoopers, 2, rue Gerhard Mercator, L-2182 Luxembourg as the statutory auditor of the Fund replacing KPMG Luxembourg *Société Coopérative* to perform the statutory audit of the financial statements of the Fund for the financial year starting January 1, 2015 and ending December 31, 2015.

The audited annual accounts of the Fund for the financial year starting January 1, 2014 and ending December 31, 2014 have been signed by KPMG Luxembourg *Société Coopérative* on 20<sup>th</sup> March 2015.

#### II. Effects on Unit holders

The Unit-holders will not bear any additional costs resulting from the auditor's change.

The above mentioned change will be reflected in a next update of the prospectus of the Fund to be effective after the October 2014 version (the "**Prospectus**").
